In 2014 ...

Demographic shifts showed consistency, becoming trends.

- The population continued to decrease due to a number of factors, including an aging population, out-migration, and a decreasing birth rate. The number of VI children (under 18) in 2014 showed a continued decline, decreasing by over 16,000 children (or 47%) since 2000. Meanwhile, the distribution of children by age group and by racial/ethnic group has remained relatively stable.
- The proportion of families (with children) headed by unmarried female householders has remained consistently high over the past several years: 52% in 2014, 53% in 2013, 52% in 2012; up from 48% in 2010...and from 37% in 1990.
- The percentage of children living in married-parent families is on the rise (36% in 2014 and 2013), approaching rates observed in 2010 and years prior (2000: 34%, 2010: 32%), but far below U.S. national rates: 65% in 2014.

Health indicators showed areas of improvement/weakness.

- More than a quarter of all VI children (26%) continued to lack health insurance (static compared to 27% in 2013 and 28% in 2012), a higher percentage than in any state, the District of Columbia, or Puerto Rico.
- The rate of babies born at low weight continued to decrease, dropping 4 percentage points from 2012 to 2014.

Economic health remained stagnant for the Territory and its families.

- Unemployment remained relatively static, decreasing by just 0.4 percentage points from 2013 to 2014 following an increase of 1.7 percentage points from 11.7% in 2012 to 13.4% in 2013.
- The child poverty rate remained on the rise, increasing to 37%, up from 35% in 2013 and 31% in 2012.
- The Territory's Gross Territorial Product continued its decline, shrinking by 1% between 2013 and 2014 (following decreases of 6%, 15%, and 8% in 2013, 2012, and 2011, respectively).

Many VI children were not reaching their full developmental/educational potential.

- Substantial numbers of VI children entering public kindergarten lacked age-expected cognition skills (39% in 2014, stable from the previous year) and word recognition and comprehension skills (51% in 2014, a continued trend from 2012) for kindergarten readiness.
- Record numbers of children were on waiting lists to access Head Start programming (447 in 2014, up from 73 in 2013).
- A majority of students were testing well below national standards on educational assessments for English Language Arts/Literacy and Mathematics.
