#### Bequest

Incorporate a statement in your will that a share of your estate, shall be distributed to CFVI for the purpose that you name.

#### Life Insurance

By assigning a life insurance policy to CFVI as owner and beneficiary, a donor's premiums are tax-deductible. When the policy is redeemed, a permanent fund is created to support the charitable goals described by the donor.

#### **Retirement Plans**

A donor advised fund is like a charitable savings account you set up at CFVI. In return, you qualify for an income tax charitable deduction for gifts to your donor advised fund. In addition to making annual gifts, you can also create a lasting legacy by naming your donor advised fund at CFVI as a beneficiary to receive your legacy gift after your lifetime.

#### **Savings Accounts & Certificates of Deposits**

A convenient way to benefit CFVI is through savings plan, including savings accounts, certificates of deposit, and other savings arrangements. All you need to do is make CFVI a joint owner of the account with rights of survivorship only.
